Richard Kidd presented a framed portrait of Capt. Jack C. Hays that will be on display outside the second-floor courtroom in the new Hays County Government Center in San Marcos. A plaque will be installed later.



Kate described the new Center for Texas Public History at Texas State University. Lynn Denton will be the new Director and Dan Utley will serve as the Center's Chief Historian. The Center, staffed by faculty and students in the department's graduate program in Public History, will make its expertise in museum work, oral history, and cultural resource management available to government agencies, museums, historical commissions, and community organizations that need help in researching and interpreting historical information for the public.

The motion passed by all members, and the meeting adjourned at 1:25 p.m. and was followed by lunch which included a cake decorated with images of HCHC meeting locations for 2011, Capt. Jack, the Hays County Courthouse, Vox Pop, etc.
